David Becker has over two decades of experience in the law of voting rights, election administration, and redistricting. In addition to founding the nonpartisan nonprofit Center for Election Innovation and Research to serve election officials of both parties, he led the Pew Elections team for The Pew Charitable Trusts, and served for seven years as a senior trial attorney in the Voting Section of the Department of Justice's Civil Rights Division. That service included a redistricting cycle, including DOJ preclearance review under the Voting Rights Act of redistricting plans in multiple jurisdictions, and litigation under the Voting Rights Act in federal court. In this role, he led investigations of potential federal voting rights violations in more than a dozen states, and served as lead trial counsel for the United States in approximately a dozen federal voting rights cases.

VICE CHAIR TURLEY DISCLOSED A MEETING WITH COMMISSIONER McCLINTOCK ON MARCH 21, 2021 REGARDING DISTRICT TWO OUTREACH EFFORTS, NOT REPORTED ON THE WEBSITE.

SCOTT RAFFERTY, HEARD REGARDING DOCUMENTS RECEIVED, EX PARTE PRACTICES, LACK OF TRANSPARENCY, WRITTEN REMARKS BEING INCLUDED IN THE POSTED AGENDA, AND THE VOTING RIGHTS ACT.

MOTION CARRIED: 9 AYES 2 ABSENT

5. Introduction of the legal team.

ANDREA ORDIN, LEGAL COUNSEL, STRUMWASSER & WOOCHER, INTRODUCED SALVADOR PEREZ, COUNSEL, AND IS ATTENDING TONIGHT'S MEETING.

6. Review by legal counsel on the Ralph M. Brown Act, including ex parte disclosures, social media communication, and communications with the press.

CHAIR MORRIS JOINED THE MEETING AT 6:13 PM.

MS. ORDIN GAVE AN OVERVIEW ON THE FOLLOWING:

- <u>EX PARTE DISCLOSURE</u>: DESIGNED FOR REPORTING CONVERSATION RELATED TO THE WORK OF THE COMMISSION, TO USE THE TOOLS AVAILABLE, ADHERE TO THE ORDINANCE TO ENSURE IMPARTIALITY, AND ERR ON THE SIDE OF FULL DISCLOSURE.
- <u>SOCIAL MEDIA</u>: THE LEGISLATION IS DESIGNED TO RESTRICT COMMUNICATION AMONG THE COMMISSIONERS ABOUT MATTERS RELATED TO THE WORK OF THE COMMISSION. SHE COMMENTED THAT "LIKING" ANOTHER COMMISSIONER'S POST CAN BE VIEWED AS HAVING A MEETING. COMMISSIONERS ARE PROHIBITED FROM INTERACTING ON SOCIAL MEDIA.
- SOCIALIZING AMONG COMMISSIONERS: CAUTIONED THAT ANYTHING THAT CAN LEAD TO DELIBERATION OR LOOK LIKE A MEETING, WITH A MAJORITY OF THE COMMISSIONERS PRESENT OR A QUORUM, MAY HAVE THE APPEARANCE OF A MEETING. SHE DESCRIBED A SERIAL MEETING, WHICH IS ALSO PROHIBITED BY THE BROWN ACT, AND ENCOURAGED COMMISSIONERS TO BRING THEIR QUESTIONS AND CONCERNS TO HER ATTENTION.

COMMISSIONER BRAY ASKED IF MENTIONING YOUR APPOINTMENT AS A COMMISSIONER TO SOMEONE AND NO OTHER DISCUSSION, IS CONSIDERED EX PARTE COMMUNICATION. MS. ORDIN STATED IT DOESN'T FIT THE PURPOSE, HOWEVER, IT CAN LEAD TO A MORE INVOLVED CONVERSATION, AND NOTHING IS WRONG WITH IT, AS LONG AS IT IS DISCLOSED.

DR. JOHNSON INQUIRED ONCE THE COMMISSION HAS MARKETING MATERIALS, IF COMMISSIONERS NEED TO DISCLOSE FORWARDING OF OFFICIAL MATERIALS. MS. ORDIN STATED ALTHOUGH IT'S PROBABLY NOT REQUIRED IN THE ORDINANCE, DISCLOSING THE INFORMATION IS A GOOD POLICY AND SHOWS TRANSPARENCY IN TERMS OF OUTREACH.

COMMISSIONER TROSKY ASKED IF HAVING LUNCH WITH ANOTHER COMMISSIONER, AND NO DISCUSSION ABOUT THE COMMISSION, SHOULD BE DISCLOSED. MS. ORDIN AND MR. PEREZ STATED THIS WOULD BE LESS THAN A QUORUM AND DOESN'T NEED TO BE DISCLOSED. DR. JOHNSON SUGGESTED WHENEVER POSSIBLE HAVE A LEGAL TEAM MEMBER ATTEND PUBLIC MEETINGS AND GATHERINGS.

PUBLIC COMMENT:

SCOTT RAFFERTY, HEARD REGARDING EX PARTE LEGAL REQUIREMENTS, THE ORDINANCE AND BYLAWS, AND SUGGESTED PUTTING OUT AND POSTING A PRESS RELEASE.

ANDY CALDWELL, HEARD REGARDING EX PARTE COMMUNICATIONS REPORTING.

VICE CHAIR TURLEY ASKED MR. PEREZ FOR AN APPROPRIATE/INAPPROPRIATE SOCIAL MEDIA POST EXAMPLE. MR. PEREZ EXPLAINED YOU ARE ALLOWED TO ANSWER QUESTIONS AND PROVIDE AND SOLICIT INFORMATION FROM THE PUBLIC. YOU ARE PROHIBITED FROM RESPONDING DIRECTLY TO ANY SOCIAL MEDIA POSTS MADE OR SHARED BY OTHER COMMISSIONERS. YOU CAN'T "LIKE, SHARE" OR IN ANYWAY PARTICIPATE OR DEMONSTRATE INTERACTION WITH ANOTHER COMMISSIONER'S POST. MR. PEREZ ALSO COMMENTED THAT A COMMISSIONER MAY INDEPENDENTLY POST THE SAME COMMISSION RELATED INFORMATION AS ANOTHER COMMISSIONER.

MRS. TILTON ANNOUNCED WRITTEN COMMENTS:

JIM FOX, WROTE REGARDING THE REDISTRICTING PROCESS AND PROVIDED A RESOURCE FOR A GUIDE FOR REDISTRICTING.

CATHERINE OVERMAN, WROTE INQUIRING HOW REDISTRICTING WILL AFFECT CARPINTERIA.

7. Outreach planning including possible formation of a subcommittee to review marketing materials.

DR. JOHNSON INTRODUCED JENNIFER NENTWIG, TRIPEPI SMITH, WHO WILL WORK

CLOSELY WITH THE COMMISSION AND COUNTY ON A GENERAL OUTREACH PLAN, SOCIAL MEDIA (CONTENT, PLATFORMS), PRESS RELEASES (VARIOUS LANGUAGES), POWERPOINT PRESENTATIONS, FLYERS, IN-PERSON FORUMS, AND ASSIST WITH WEBSITE CONTENT AND PLATFORM.

CHAIR MORRIS MENTIONED PREVIOUS DISCUSSION OF A SUB COMMITTEE AND THE APPOINTMENT OF COMMISSIONER BRAY AND HUDLEY, AND VICE CHAIR TURLEY TO THE SUB COMMITTEE THAT WILL BE THE COMMISSION'S CONTACT WITH TRIPEPI SMITH STAFF. DR. JOHNSON STATED THAT TRIPEPI SMITH IS THERE TO SUPPORT THE COMMISSION. MS. DePINTO COMMENTED THE COUNTY WILL WORK IN UNISON WITH TRIPEPI SMITH TO SUPPORT THE COMMISSION.

COMMISSIONER BRAY ASKED ABOUT TRIPEPI SMITH'S FAMILIARITY WITH SANTA BARBARA COUNTY. MS. NENTWIG MENTIONED TRIPEPI SMITH HAS WORKED WITH THE COUNTY IN THE PAST. THEIR RESEARCH INCLUDES UNDERSTANDING DEMOGRAPHIC INFORMATION, PRIOR YEAR ELECTION DATA, ASSESSING THE ENVIRONMENT, AND ENGAGING WITH THE COMMISSION.

COMMISSIONER RIOS COMMENTED ABOUT UNIQUE COMMUNITIES, OUTREACH MATERIALS, AND RECOMMENDED THE SUB COMMITTEE INCLUDE OUTREACH GROUPS THAT CONNECT WITH HARD-TO-REACH COMMUNITIES. MS. DePINTO STATED THE COUNTY HAS MANY RESOURCES AND WILL WORK CLOSELY WITH TRIPEPI SMITH AND THE COMMISSION.

VICE CHAIR TURLEY RECOMMENDED AT LEAST ONE PERSON ON THE SUB COMMITTEE SPEAK SPANISH. COMMISSIONER RIOS VOLUNTEERED AND WAS APPOINTED TO THE SUB COMMITTEE. MS. DePINTO STATED THAT THE COUNTY WILL USE CERTIFIED TRANSLATION. DR. JOHNSON ESTIMATED THE COST WOULD BE UNDER \$50,000 ON A TIME AND MATERIALS BASIS.

8. Training 4: Review of redistricting criteria to be used in drawing maps.

DR. JOHNSON PRESENTED INFORMATION ON THE ELECTIONS CODE SECTION 21500, AND REVIEWED THE FOLLOWING CRITERIA:

- EQUAL POPULATION
- FEDERAL VOTING RIGHTS ACT
- CALIFORNIA VOTING RIGHTS ACT
- COMBINED CRITERION
- CONTIGUOUS
- NEIGHBORHOODS AND COMMUNITIES OF INTEREST
- COMPACT

VICE CHAIR TURLEY ASKED ABOUT INCARCERATED POPULATION DATA. DR. JOHNSON EXPLAINED THE STATE WILL ZERO OUT THE PRISON COUNT AND MOVE INDIVIDUALS TO THEIR LAST KNOWN HOME ADDRESS AND COUNTY JAIL INMATES WILL BE COUNTED. HOWEVER, THERE HAS BEEN NO FINAL DECISION ON FEDERAL PRISONERS IN LOMPOC, AS HOME ADDRESS INFORMATION FOR FEDERAL PRISONERS IS NOT AVAILABLE.

DR. JOHNSON AND MS. ORDIN EXPLAINED THE DIFFERENCE IN THE LANGUAGE CHANGE IN THE ELECTIONS CODE SECTION 21500, FROM "MAY CONSIDER" TO "SHALL CONSIDER".

COMMISSIONER McCLINTOCK COMMENTED ABOUT THE RULES OR FORMULA FOR MEASURING COMPACTNESS. DR. JOHNSON STATED NDC HAS TOOLS AND CAN ASSIST THE COMMISSION.

COMMISSIONER BRADLEY COMMENTED ABOUT COHESIVENESS AND HOW COMMUTING IS WEIGHED, AS PEOPLE COMMUTE BETWEEN DISTRICTS FROM HOME TO WORK. DR. JOHNSON STATED THE DECISION IS AT THE COMMISSIONERS' DISCRETION.

PUBLIC COMMENT:

ANDY CALDWELL, HEARD AND ASKED ABOUT THE VANDENBERG AIR FORCE BASE POPULATION (INCLUDING TEMPORARY DUTY, AND MISSION SPECIFIC), AND EXPRESSED CONCERNS ABOUT MILITARY PERSONNEL BEING COUNTED IN THE CENSUS AND BE A REGISTERED VOTER SOMEWHERE ELSE, AND COMMENTED ON MAP DRAWING.

DR. JOHNSON COMMENTED THE COUNT FOR VANDENBERG AIR FORCE BASE SHOULD BE PEOPLE WHO WERE AT LEAST A SEMI-PERMANENT RESIDENT AS OF APRIL 1, 2020. DR. JOHNSON ALSO EXPLAINED THE FAIR MAPS ACT, AND STATED THAT NDC WILL HELP THE COMMISSION JUDGE THE MAPS SUBMITTED BY THE PUBLIC.

COMMISSIONER BRADLEY ASKED ABOUT THE LOS PADRES NATIONAL FOREST, ITS IMPACT ON HOW MAPS ARE DRAWN, AND HOW IT COMPARES TO A GEOGRAPHIC FEATURE. DR. JOHNSON COMMENTED THAT AFTER HEARING PUBLIC COMMENTS, IT WILL BE THE COMMISSION'S DECISION.
