Chair Morris and Members of the Redistricting Committee:

I am pleased to strongly recommend the services of National Demographics, Inc. (NDC) to the County of Santa Barbara to assist in the 2020 redistricting of County electoral districts. I was privileged to serve as incorporation counsel and later as City Attorney for the City of Goleta from 2000 to 2008 when it was formed and organized its electoral districts. Despite those issues, in every case where I was privileged to assist NDC in redistricting or establishment of a new electoral process, NDC has provided the

expertise necessary to process such changes fairly and with sensitivity to community needs and the clients were extremely pleased with the process and standards followed by NDC.

My name is Kendall James, I am a resident of Santa Barbara County. As you begin the interview process of forming a complete commission, I'm writing to emphasize the importance of the commission to reflect the **demographic**, **geographic**, and **political diversity** of Santa Barbara County. Women of color must be represented, our Hispanic/Latino, Black, Native, and Asian population must be represented.

I understand and heard the commission bring attention to the fact that the candidate pool is overwhelmingly white, male, and 60+, so it may be more difficult to choose a commission that is representative of our diverse communities, regardless, this should not inhibit the formation of a diverse commission that is representative of the County. I urge you to be mindful about why this is the case and think about what systems are set up that discourage people of different ethic backgrounds, gender identities, and ages from feeling like they have a role in decision making for their community. There are many candidates who have been included on your slates, such as Jannet Rios, James Hudley, Lata Murti, and Amanda Ochoa, along with others, who are representative of the County's diversity that are not yet represented on the commission.

I'd also like to bring attention to Cheryl Trosky's concerning letters submitted to the SB Independent regarding disapproval of COVID safety measures and the "oppressive lockdown." It's hard to imagine someone who is resistant to making the sacrifice to stay home during a pandemic because there is "no joy in the experience [of grocery shopping]" would work hard to ensure the people who are living in our County, especially our underrepresented community members, are fairly represented and made a priority in these redistricting efforts.

Inclusivity matters. Representation matters. We need a commission that prioritizes this.

The independent redistricting commission of Santa Barbara County is the first of its kind for California counties. San Diego County is the only other County with an independent commission; however, their team consists only of five members and two alternates, as opposed to our county's eleven members. More members allow for more opportunity for the diverse communities, industries and voices of all residents to be heard and represented.

According to Measure G, the ordinance approved by voters in 2018 and providing the guidelines for this independent redistricting process: members of this commission shall, as closely as possible, reflect the ethnic, gender, age, and geographic diversity of Santa Barbara County. Moreover, Measure G is written in a manner that emphasizes political party preference as a secondary consideration for selecting members.

We at Econ Alliance, a nonprofit organization that began as a grass roots effort of a diverse group of North County economic and community leaders interested in increasing family-wage jobs through innovation and support, agree with the language and goal set forth by Measure G.

With all facets of life being politicized in these polarizing times, we believe using the given criteria other than political party affiliation will create the most cohesive and independent body possible—resulting in an independent and diverse commission where geographic diversity, life and work experience and knowledge of the region take precedence over partisan ideals and motives. This is the goal of Measure G.

Of the current five members chosen by random drawing on October 13, four of them are male, all of them are white, and two of them are educators. It goes without saying that there should be more than a 1:4 ratio of women to men. Also, Santa Barbara County is 43.8 percent white, 46 percent Hispanic, 6 percent Asian, and 2.4 percent African American. We would like to see a more accurate ethnic representation of our County on the commission.

Of the remaining 37 members from the top 45 most qualified applicants, many of them are associated in some way with education. The residents of Santa Barbara County need commissioners to represent a wide array of demographics, professions, industries, and geographic areas of the county. No commissioners who were chosen on October 13 are involved in agriculture, a vital and extensive industry in Santa Barbara County. The voices of farmers and ranchers must be heard on this commission. We also need representatives from a diverse range of professions and regions, who have extensive experience in various communities and a resume that exemplifies their commitment to the overall success of our County.

If these representatives are selected, we can ensure problems with the last redistricting process and the current makeup of county lines are corrected for the greater good. For example, District 3 is geographically inflated to include areas from Guadalupe to Isla Vista. The city of Guadalupe has been disenfranchised for the past ten years and drowned out by the areas with more political influence. Guadalupe is

unique from the southern parts of the district and possesses considerably different needs.

To create the most diverse, cohesive commission possible, residents should be chosen from all areas of the county, all backgrounds, and all industries, and political affiliation should play only a secondary role in determining the additional members of this independent commission.
