Firm Description. The Sutton Law Firm is a full-service political law firm, specializing in federal, state and local government law, as well as campaign and election law. The Firm's main office is in San Francisco, and we maintain additional offices in Los Angeles and Sacramento. Our clients include public agencies, public officials, candidates, corporations and nonprofit organizations, as well as a range of others engaged in the political and governmental process. We currently represent cities, counties and special districts as outside counsel on a range of matters, including as independent counsel on the Brown Act, Public Records Act, ethics and conflict of interest laws. We are a nonpartisan firm, and we assist clients across the political spectrum.

Assigned Personnel. Nick Sanders would serve as the overall lead for this engagement and the primary service provider in the role of the Commission's Legal Counsel. Mr. Sanders has nearly 12 years of experience in the areas of political and election law, including more than five years of experience as a campaign and election law attorney. Mr. Sanders attended both undergraduate and law school at UC Davis, and has been a member of the California Bar since 2015.

Prior to law school, Mr. Sanders spent four years in a staff capacity at Nielsen Merksamer, another government, campaign and election law firm. During law school, he worked as a research assistant studying the federal Voting Rights Act; as a campaign and election law compliance clerk for a nationwide advocacy group; in the legal division of the California Fair Political Practices Commission; and spent a semester working full-time in the office of Commissioner Ann Ravel at the Federal Election Commission. Mr. Sanders also assists the California State Senate and Assembly Ethics Committees in presenting their legally-mandated lobbyist ethics training, and is currently an adjunct professor of Election Law at UC Davis School of Law.

Brad Hertz would also regularly engage with the Commission and provide legal advice and services, as needed. Mr. Hertz is a partner at the Sutton Law Firm and has 32 years of experience in campaign and election law, with a specific emphasis on litigation. He graduated from Brown University in 1985 and Georgetown University Law Center in 1988. Mr. Hertz worked for the Buchalter Nemer law firm from 1988 to 1990, the campaign and election law firm of Reed & Davidson from 1990 to 2011, and the Sutton Law Firm since 2011.

For several years, Mr. Hertz served as an Adjunct Professor of Election Law, and also taught California Civil Procedure at Chapman University Law School. He is Past President of the California Political Attorneys Association, was a Los Angeles Superior Court volunteer mediator from 2002 through 2011, and has been nominated as a "Trusted Advisor" attorney by the San Fernando Valley Business Journal.

In addition to Mr. Sanders and Mr. Hertz, associates Dale Bellitto and J.P. Fisher are expected to provide additional legal support to the Commission, as needed. Ms. Bellitto graduated from Dartmouth University in 2016 and the University of Michigan School of Law in 2019 and is a member of the California and Illinois Bars. Mr. Fisher graduated from Bard College in 2017 and Hastings College of the Law in 2020. He became a member of the California Bar this month.

Resumes for these Sutton Law Firm attorneys are attached hereto as Exhibit A and incorporated herein.

Experience. The Sutton Law Firm currently represents cities, counties and special districts as outside counsel on a range of matters, including as independent counsel advising on the Brown Act, the Public Records Act, ethics and conflict of interest laws. The Firm also acts as outside counsel for litigation on behalf of public entities, and provides general advice on government, campaign and election law matters. The Firm provides legal advice regarding state and federal reapportionment and voting rights laws to non-governmental clients, but has not litigated redistricting or voting rights cases. We have not acted as independent counsel to any other local jurisdictions on redistricting or voting rights law. Even so, we are familiar with all relevant laws and fully capable of advising the Commission on reapportionment, voting rights and related issues.

In addition, both Mr. Sanders and Mr. Hertz have extensive experience communicating about these laws to individuals and groups with various levels of expertise. Mr. Sanders and Mr. Hertz have provided numerous educational trainings to elected and appointed officials and public employees regarding, among other things, the Brown Act, the Public Records Act, the Political Reform Act, and ethics and conflict of interest laws. Both regularly host seminars on governmental, campaign, ethics, election and related laws.

Additional Information (Conflicts). Our Firm has no legal conflicts, though we do provide occasional advice to the County of Santa Barbara Office of County Counsel on unrelated matters. We have run a conflicts check, reviewed Elections Code section 23003 and Santa Barbara County Code Sections 2-10.9A(5)(d) and (4)(d), and we confirm that anyone from the Firm who would be assigned to provide services under the contract would not be disqualified under these, or any other, provisions of law.

<u>Fees</u>. In recognition of the importance of the Commission's work, and with an understanding that the Commission is a public entity spending public money, we would bill at our best, lowest hourly billing rates. These rates are \$250 per hour for Mr. Sanders; \$400 per hour for Mr. Hertz; \$155 to \$200 per hour for Ms. Bellitto and Mr. Fisher; and \$140 for law clerks.

At this stage of the process, we are not able to provide an estimate of the total fee and/or expected range, or a not-to-exceed amount, and fees would be determined in advance based on the level of activity necessary to accomplish the Commission's goals. Only necessary expenses will be billed to the Commission – for example, costs incurred for legal research or court filings. The Sutton Law Firm will not bill for any expenses which are not directly related to Commission work – for example, attorneys will not request reimbursement for meals.

<u>Form Contract</u>. The Sutton Law Firm proposes no changes to the form contract provided by the Commission, and we would raise any specific concerns in the unlikely event that any issues arise.
