Interest: Think globally act locally

I have long been interested in helping my community. I serve best on defined tasks and have little interest in being involved in political maneuvering. I believe the Independent Redistricting Commission offers an opportunity to serve the region in this capacity, and take part in a process that aims to achieve fairness for both the short and long term. Santa Barbara County is both unique and diverse, and I think my experience makes me uniquely qualified to be a member of a commission dedicated to providing the fairest representation for everyone throughout the process.

Experience:

I think my experience has given me the analytical capacity, management capability, and procedural awareness to not only help on this project, but also be an asset to the team.

I am a scientist by training (PhD in nuclear physics). I worked at a "job" for 14 years and have worked for myself since then. My company (Mirmar Sensor, LLC) did many government contracts based in Santa Barbara County—employing about 12 people at the peak. Our specialty is nuclear detection and for over a decade, we have analyzed data and used that information to develop theories and form answers to questions or solutions to problems. A significant portion of my work was training elected officials in emergency response, so I have been exposed to the political process and have an understanding of what is to be expected during the public hearings to be held in 2021.

My local service has also been best to offer hands-on help. I ran the trail maintenance program for the Sierra Club for several years and I was the Santa Barbara representative on the Sierra Club regional board for a bit. I was active in the amateur radio emergency services (ARES) and later also in the Los Padres Search and Rescue Team.

Although "retired" I do not like to sit still. When I "retired" I transitioned my company to import handmade products from the Philippines. The reason for that big switch was: I had friends in the Philippines. One of these friends was lost for 6 weeks in Typhoon Yolanda, which killed more than 6000 people. While worried about my friend, I saw that governments and non-governmental organizations were giving aid these people things, but they were not developing jobs. I thought I could help. I do not make much money at my import business but I have created a few dozen jobs for people who would otherwise have none.

A career in physics research proves I have the analytical skills to design 5 equitable districts for Santa Barbara County. The development of responsible jobs for people who do not know the profit-making work ethic in the Philippines has given me nearly infinite patience to listen and resolve. My experience with Santa Barbara County volunteer efforts has exposed me to the dynamics of the County. I have not been involved in party politics at any time, but voting and taking part in the Democratic Process is something I do and is extremely important.
