VICE CHAIR TURLEY COMMENTED ABOUT THE CANDIDATE POOL'S LACK OF DIVERSITY, ETHNIC REPRESENTATION, THE IMPORTANCE OF APPEARANCE AND IMPARTIALITY, AND SUPPORTS CANDIDATE KEVIN KASEFF.

COMMISSIONER RIOS EXPRESSED CONCERN ABOUT CONFLICT OF INTEREST WITH LUPE ALVAREZ, AND THE IMPORTANCE OF ETHNICITY.

COMMISSIONER TWIBELL INQUIRED ABOUT THE RELEVANCY OF THE ARTICLE FROM 2010 REFERENCING LUPE ALVAREZ.

COMMISSIONER BRAY COMMENTED ABOUT CANDIDATE SELECTION AND THE ORDINANCE.

COMMISSIONER McCLINTOCK COMMENTED ABOUT THE IMPORTANCE OF PARTISAN BALANCE, AND THE NEED FOR LUPE ALVAREZ'S INVOLVEMENT IN THE PROCESS.

COMMISSIONER ADAMS MENTIONED THAT THE SELECTION MUST BE MADE FROM THE POOL, EXPRESSED CONCERN REGARDING LUPE ALVAREZ'S LEVEL OF IMPARTIALITY, AND SUPPORTS APPOINTING A DEMOCRAT AND CANDIDATE KEVIN KASEFF.

JACQUELYNE ALEXANDER, COUNTY OF SANTA BARBARA, ADMINISTERED THE OATH OF OFFICE TO KEVIN KASEFF.

RECESSED THE MEETING AT 8:11 PM, AND RECONVENED AT 8:16 PM.

9. Training 7: Outreach presentations, talking points, website, and marketing materials. Review by legal counsel on the Ralph M. Brown Act, including ex parte disclosures, social media communications, and communications with the press.

MRS. TILTON INTRODUCED RYDER SMITH AND JERALD LA MADRID FROM TRIPEPI SMITH, AND GAVE AN OVERVIEW AND DEMONSTRATION OF THE WEBSITE. THE WEBSITE WILL HAVE A NEW URL AND MUST REMAIN LIVE FOR 10 YEARS.

COMMISSIONER BRADLEY ASKED WHAT THE PLANS ARE FOR ORGANIZING PAPER MAPS. MRS. TILTON STATED THEY WILL BE TREATED LIKE AN ONLINE MAP, AND NDC WILL PRODUCE THE MAP.

COMMISSIONER BRAY ASKED IF THE EXISTING WEBSITE WILL AUTOMATICALLY REDIRECT USERS TO THE NEW WEBSITE. MR. SMITH STATED THERE WILL BE TEXT ON TOP OF THE EXISTING WEBPAGE WITH A LINK TO THE NEW WEBSITE.

COMMISSIONER McCLINTOCK SUGGESTED PAPER AND HAND DRAWN MAPS BE SCANNED AND MADE AVAILABLE TO THE PUBLIC. NDC STATED ALTHOUGH THE ORIGINAL MAP SUBMISSIONS TYPICALLY ARE NOT POSTED ON THE WEBSITE, THEY ARE KEPT IN THE PUBLIC COMMENTS HISTORY.

COMMISSIONER TROSKY ASKED WHO WILL MONITOR THE EMAIL. MRS. TILTON STATED THAT FOR PUBLIC RECORDS ACT REQUESTS AND RECORD KEEPING PURPOSES, THE COUNTY WILL RECEIVE THE REQUESTS, AND FORWARD TO NDC FOR PROCESSING AND RESPONSE.

COMMISSIONER ADAMS ASKED IF THE WEBSITE PAGE WILL BE BILINGUAL. MR. SMITH STATED THAT THEY ARE WORKING ON THE WEBSITE'S SPANISH TRANSLATION, AND GOOGLE TRANSLATOR WILL BE AVAILABLE TO TRANSLATE TEXT ON THE WEBPAGE IN MANY LANGUAGES. COMMISSIONER ADAMS EXPRESSED CONCERNS ABOUT CITIZENS RESPONSES TO EMAILS SUBMITTED THROUGH THE COUNTY AND QUESTIONED IF COMMISSIONERS SHOULD RECEIVE INFORMATION ABOUT EMAILS FROM CITIZENS. MS. ORDIN REVIEWED THE SECTION OF THE BYLAWS THAT ADDRESSES EMAIL COMMUNICATIONS.

VICE CHAIR TURLEY SUGGESTED CREATING A LISTSERV (SUBSCRIBE TO THE LISTSERV AND WHEN AN EMAIL IS SENT FROM THE LISTSERV, IT GOES TO ALL SUBSCRIBERS). DR. JOHNSON CAUTIONED THAT EMAILS COULD BE MISSED AND BECOME PROBLEMATIC. COMMISSIONER TROSKY COMMENTED THAT THE NUMBER

OF EMAILS RECEIVED COULD BE OVERWHELMING, AND COMMISSIONER ADAMS OPPOSES THE POSSIBILITY OF RECEIVING MORE EMAILS.

MRS. TILTON GAVE AN OVERVIEW OF AND DEMONSTRATED THE POWERPOINT PRESENTATION (INTRODUCTION FOR INITIAL PUBLIC OUTREACH) TO ENGAGE, EDUCATE AND EMPOWER RESIDENTS.

CHAIR MORRIS ASKED WHEN THE PRESENTATION WILL BE AVAILABLE, AND MR. SMITH STATED, IF NO MAJOR CHANGES, IT SHOULD BE AVAILABLE IN 48 HOURS.

COMMISSIONER McCLINTOCK ASKED ABOUT THE "WHO DRAWS THE LINES" SLIDE, AND CLARIFICATION REGARDING COMMISSIONERS DRAWING/NOT DRAWING MAPS. MS. ORDIN STATED THAT COMMISSIONERS CANNOT DRAW MAPS AT ALL PRIOR TO THE FIRST SEVEN (7) HEARINGS. DR. JOHNSON STATED THAT COMMISSIONERS NOR NDC CAN DRAW ANY MAPS UNTIL THE OFFICIAL CENSUS DATA IS RELEASED, AND ONLY RESIDENTS CAN START DRAWING MAPS.

"WHO DRAWS THE LINES?" SLIDE CHANGE SUGGESTIONS:

COMMISSIONER BRADLEY EXPRESSED CONCERNS ABOUT RESIDENTS FOCUSING ON WHAT LINES THEY DO NOT WANT AND RECOMMENDED THE SLIDES HAVE AN AFFIRMING TONE.

MS. ORDIN RECOMMENDED A MEETING WITH NDC TOMORROW TO ADDRESS THE CONCERNS AND SUGGESTIONS.

COMMISSIONER KASEFF COMMENTED THAT ON THE "WHO DRAW'S THE LINES?" SLIDE, THE BULLET POINT BELOW THE HEADING DISCUSSES THE COMMISSION, AND MAY BE INTERPRETED TO MEAN THE COMMISSION IS RESPONSIBLE FOR DRAWING

THE LINES.

CHAIR MORRIS COMMENTED ABOUT COMMISSIONERS DRAWING MAPS, AND THE COMMISSION'S ROLE TO GATHER MAPS FROM THE PUBLIC.

COMMISSIONER TWIBELL SUGGESTED COMBINING THE "ENGAGING RESIDENTS" AND "YOU DRAW THE LINES" SLIDE, AND ADDING "WHAT THE COMMISSION IS" RIGHT BEFORE COMMISSIONER BIOS.

COMMISSIONER ADAMS SUGGESTED USING "WHAT WE DO" TO DESCRIBE THE COMMISSION'S WORK.

MS. ORDIN PRESENTED INFORMATION ON GUIDANCE ON PUBLIC OUTREACH MEETINGS:

MRS. TILTON STATED THAT NDC WILL SEND THE PRESENTATION SLIDES TO COMMISSIONERS AND POST ON THE WEBSITE. TRIPEPI SMITH IS RESPONSIBLE FOR PROVIDING THE OUTREACH MATERIALS (FORMS, POWERPOINT, VIDEO ACCESS, AND WEBSITE TIMELINE) TO THE COMMISSIONERS.

COMMISSIONER BRAY ASKED WHO WILL BE RESPONSIBLE FOR ENSURING THAT COMMISSIONERS DO NOT BOOK THE SAME EVENT. DR. JOHNSON STATED THAT NDC AND TRIPEPI SMITH WILL COORDINATE MEETINGS.

MR. SMITH WAS NOT ABLE TO PRESENT THE VIDEO DUE TO TECHNICAL DIFFICULTIES, HOWEVER, THE LINK WILL BE POSTED ON THE WEBSITE.
