Dear Chair Morris and Members of the Commission
I wanted to submit this public comment in response to some of the things said last night regarding Jannet Rios and her reappointment to the Commission to fill the at-large vacancy.

It astonishes me that speakers felt entitled to call Ms. Rios a quitter. Several other commissioners have resigned, when a new job or a prior commitment called them -- were they quitters also? The pandemic has stretched out this Commission service far beyond what was imagined when you all applied, as I am sure I do not need to tell you. The original schedule would have meant that your service was done by the end of the summer, not far into the fall. People, especially younger working people, have to make economic and professional choices, and especially in a crisis like this pandemic, those choices can be very complicated. Ms. Rios was pursuing a professional opportunity, and then circumstances intervened. Surely that has happened to all of us at least once in our lives.

That aside, I want to it reiterate what you already know about her qualifications for the job, since many of you interviewed her for her original appointment. Ms. Rios is the child of Latinx immigrant parents who worked in the fields and continue to hold working class jobs, making them very much reflective of a significant part of our county residents. She was born and raised in Santa Maria, is a fluent bilingual speaker (who provided some very valuable translation from time to time), and is very tied to that community. In her professional life she also works with a wide range of individuals and communities which positions her well to understand and reflect those concerns in Commission decision-making. Further, she represents a youth demographic that is underrepresented, although Vice-Chair Turley has done an exceptional job. This is an opportunity for the younger, minority residents of our County to see themselves represented on the Commission again.

Ms. Rios was a dedicated commissioner during her service, which only ended recently. This means she is prepared to come back and do the work, whereas another appointee would have to be brought up to speed after having missed all of the Commission's preparatory work, including all of the community input that is so essential to your decisions going forward.

I would also respectfully disagree with Ms. Ordin about your option of not appointing a replacement. The ordinance which created this Commission is the controlling law -- not your bylaws, which only allow you to define discretionary choices. On the number and nature of the commissioners, the ordinance is clear per subsection (j)(C) (3):
"If any vacancy occurs on the commission by reason of the death, removal or resignation of any commissioner, the remaining members of the commission shall [emphasis added] select a replacement commissioner from the pool of most qualified applicants previously selected by the county elections officer, utilizing the criteria set forth in subsection (4) (h) (3). To the extent practical the replacement commissioner shall be selected to maintain the balance of district representation and political affiliations that existed prior to the vacancy."

As you were instructed last night, the word 'shall' under law determines that an action is mandatory. So you are mandated to appoint a replacement. The matter might be more complicated if there were no approved candidates left from the original pool of 45 , but that is not the case.

Ms. Rios meets all the requirements, including maintaining the balance of district representation (as Dr. Adams was also from Santa Maria) and political affiliation (both being Democrats). She reflects the democraphic diversity that we have so desperately needed, around race and age. She has the experience and preparation. She has proven herself by past performance. As I have said too many times now, we do not want the work of the Commission derailed by a lawsuit that successfully nullifies it for deviating from the mandates in the ordinance. Failure to (re)appoint Ms. Rios risks exactly that.

Thank you for all your service, and for navigating a series of hurdles and challenges, including this one. Fortunately, Ms. Rios' availability makes this an easy fix.

Dear Commission Members:
This letter is submitted on behalf of the Santa Barbara County Democratic Central Committee. The Independent Redistricting Commission ("Commission") is unfortunately again in the position of having to fill a vacancy on the Commission, this time due to the tragic loss of former Commissioner Kate Adams. We understand that former Commissioner Janet Rios is available and willing to fill the vacancy, but that there may be opposition from some quarters to her resuming a position on the Commission. There is no valid basis for opposition, or for leaving the vacant At-Large seat on the Commission open.

Ms. Rios is obviously very well qualified for the position. Her previous service on the Commission also gives her the tremendous advantage of being familiar with the Commission's goals and operating procedures, and thus the ability to enter into the redistricting process at this late date with minimal catch-up.

As far as the rules governing appointment of replacements, the Commission members are no doubt already familiar with the relevant provisions of the Independent Redistricting Commission Ordinance. Subsection 2-10.9A(4)(j)(1)(C)(3) of the Ordinance provides:
"If any vacancy occurs in the commission by reason of the death, removal or resignation of any commissioner, the remaining members of the commission shall select a replacement commissioner from the pool of most qualified applicants previously selected by the county elections officer, utilizing the criteria set for in subsection (4)(h)(3). To the extent practical the replacement commissioner shall be selected to maintain the balance of district representation and political affiliations that existed prior to the vacancy."

As use of the word "shall" in the first sentence of this subsection indicates, the duty to select a replacement is mandatory. This only makes sense. The Commission is intended to operate as an eleven member representative body. The at-large position in particular is important to ensure that a county-wide perspective is represented on the Commission. In a worst case scenario, reducing the number of Commissioners to ten could also jeopardize the Commission's ability to reach the seven vote majority necessary to approve a redistricting plan. (Subsection 210.9A(6)(h).)

The second sentence of $2-10.9 \mathrm{~A}(4)(\mathrm{j})(1)(\mathrm{C})(3)$ mandates that the proportional balance of political representation on the Commission be maintained, if at all possible, by the appointment of a replacement with the same political affiliation as the Commissioner being replaced. The Commission is by now very familiar with this requirement. Ms. Adams was a registered Democrat and Ms. Rios is a registered Democrat. Appointment of a Republican applicant at this time would completely upset the proportional balance the Commission has so far successfully maintained in compliance with subsection 2.10-9A(4)(h)(3). Appointment of Ms. Rios would also further two other aspirational diversity goals of subsection 2.10-9A(4)(h)(3), i.e., by improving representation of Hispanic residents of the County, and better reflecting gender diversity on the Commission, which is currently comprised of four female and six male Commissioners.

The Commission has honored the provisions of the Ordinance in the past when the choices among applicants were more difficult. There should be no difficulty now in selecting such a highly qualified replacement Commissioner as Ms. Rios to fill the current vacancy.

Dear Committee: I have the following suggestions for the new district map.

Please keep Vandenberg Village, Mesa Oaks, and Mission Hills together. In the past, they have split these areas. Right now we are in the same district. We share the same water aquifer so they should be kept together.

Please keep IV in the 3rd district. IV and UCSB are in the coastal zone and it makes sense to keep them in other coastal zone areas, such as Gaviota.

Please keep Gaviota Coast in the 3rd district. Those living on ag. properties (e.g. Hollister Ranch) should be kept with other ag. owners, such as those in the 3rd district

Harris Grade Road on the south side of the crest should be in the 3rd district, with the residential areas. This is especially important in the area of the LOGP. If there is a catastrophic event at the plant, the surrounding residential areas will be most negatively impacted. It makes sense to keep them together. Right now, the current map carved out the plant from the surrounding 3rd district. Many sensed this was 'political'.

This is submitted on behalf of my client, The California Hispanic Chambers of Commerce. My client has authorized me to comment succinctly on the Commission's abundantly clear record of denying the county's largest ethnic group of any semblance of fair representation on the Commission as well as its blatant disregard of the governing law, Brown Act procedures and its own bylaws. (See letters of December 19, 2020, January 17 and 28, 2021, April 21, 2021, May 15, 2021 and October 4, 2021). This letter summarizes the egregious errors of the Commission to date.

The Commission and Commissioners should be prepared for a litigation hold (agency and personal documents retention demand) letter if the Commission and individual commissioners fail to correct this situation to the extent possible with the upcoming appointment of a replacement for the vacant At Large Commissioner position.

The Commission by its actions has ignored the clear requirement of Ordinance No. 5051 and the Ralph M. Brown Public Meeting Act in the following ways:
1. The Commission has insisted - contrary to the clear contrary commands of Ordinance No. 5051 (Section 2-10.9A(4)(j)(3) and Sec. 2-10.9A(4)(j)(3)) - that meeting partisan balance composition requirements takes priority over ensuring ethnic/racial/gender/geographic balance. As a result, even if the Commission chooses an Hispanic replacement commissioner, Hispanics will remain substantially (50\%) underrepresented relative to their percentage of the County's population ( \(18.2 \%\) on the Commission; \(39.4 \%\) of the County's population.)
2. While denying representation and a voice to Hispanic citizens of the County, the Commission has taken extraordinary steps over numerous meetings to appoint a majority of Democrats as Commissioners, resulting in substantial overrepresentation of Democrats. For example, reappointing resigned former Commissioner Rios would result in Democrats constituting \(59.4 \%\) of Commissioners compared to their \(46.4 \%\) of the County's population.

Even without reappointing resigned former Commissioner Rios or any other remaining Democrat in the pool of remaining applicants distributed with the upcoming meeting agenda, Democrats would be slightly overrepresented relative to their percentage of the County's population.
3. The Commission violated the Ralph M. Brown Public Meeting Act on May 5, 2021, by conducting an unnoticed special meeting and/or conducting a meeting on an unnoticed agenda item (see Agenda Item No. 8) to restore Kevin Kaseff, who had previously withdrawn his name from consideration, to the list of eligible candidates for appointment to a vacancy in the At Large Commissioner position. Mr. Kaseff subsequently was appointed to fill a Third District vacancy. Two key provisions of the Brown Act that ensure that the public's business is conducted openly are the requirements that legislative bodies post agendas prior to their meetings (Sections 54954.2, 54955 and 54956) and that no action or discussion may occur on items or subjects not listed on the posted agenda (Section 54954.2(a)(2)).
4. The Commission posted an inaccurate list of the remaining applicants, that fails to identify resigned former Commissioner Rios' history. The table is blank as to Ms. Rios' status, which misrepresents the fact that she was appointed and resigned from her position.

SUBJECT: Please update census data on your mapping tools website and extend the deadline for maps submission.

Dear Commissioners,
The League of Women Voters of Santa Barbara (LWVSB) has in previous letters, urged the Commission to act in an open, public, and transparent manner. We urge you to extend the deadline for map submission. As of noon today - Wednesday October 13th -the updated Census data are not available for use in the electronic mapping tools on your website. In the interest of fairness and transparency, the public needs the most accurate, up-to-date information in order to draw maps and evaluate maps drawn by the Commission.

The only information available to the public is for the 2020 population based on an outdated community survey that was processed by the National Demographic Corporation. This information skews the numbers dramatically. For example, the data for the "old" 3rd District shows that there are 5,865 people who need to be moved from the District - and the "new" data provided to your Commission on October 6, 2021 shows there are 18 people who need to be moved. That's a large difference, and any maps based on the old/incorrect estimates are not valid.

The deadline for the public to submit maps is less than one week away. To impose a deadline without giving the public access to the updated data is irresponsible. It does not generate trust in an open, public, and transparent process.

Similarly, it is unfair to have only one hearing to review and select or reject maps from consideration. Extending the deadline for at least one week past the day that the County provides full updated Census data to the public would be much more reasonable.

Please clarify the process and allow the public to continue to submit maps and/or map revisions based on updated data that have been made public.

Chair Morris and fellow members of the Independent Redistricting Commission of Santa Barbara County,

My name is Jaime Flores and I am a Santa Maria Native, local business owner and 3rd generation SB County resident.

The current districts do not properly represent the diversity of Santa Barbara County -North to south or east to west. This misrepresentation was a product of decisions made by elected officials ten years ago. Fortunately, voters in our County, myself included, passed Measure G in 2018, and now we have an independent process in which our communities have the chance for appropriate leadership and districts in which they can all have a voice.

The block file that I have provided uses 2020 census data and as the population has started to shift to the north county; it gives our commissioners a real chance to adopt lines that accurately join communities of interest as well as regions with similarities

For instance, there are two legitimate south county districts- keeping the colleges as well as Isla Vista together in District 2 and ensuring the residents of Cuyama are paired with the existing fifth district. Folks from Cuyama go either east to the valley or west to Santa Maria when they go to a city or need to do their shopping; they don't take the three-hour trip to Montecito where there is no direct path and no commonalities.

Also, there is a balanced amount of unincorporated communities within each of the five districts presented, while keeping those areas whole and only splitting the larger cities and/or urban areas in the County.

Please confirm that this file format works for you as well as the commission and will be considered as a map submitted by the public for discussion amongst the members of the independent commission.
